## Manitoba Hydro to quantify the U.S. opportunity sales in 2004 and 2005 that were made on-peak. Also, for 2005 and 2006, MH to break down the 13,000 GWh sold to the U.S. by on-peak and off-peak.

Table 1 includes monthly USA dependable and opportunity export sales disaggregated into on and off-peak, where possible.

Disaggregated sales data by on-peak/off-peak is no longer readily available for the period prior to 2005/06 as Manitoba Hydro converted to a new energy scheduling and settlement tracking system early in 2005 in preparation for MISO Day 2, effective April 1, 2005. The legacy system is no longer functional for this type of analysis (reference GRA 2008 COALITION/MH II-32).

However, it is reasonable to assume that almost all of the 2004/05 dependable sales were during the on-peak period, similar to 2005/06. To the extent possible, depending on timing of water conditions, available generation and tie-line capacity, and market constraints, Manitoba Hydro would have first maximized on-peak opportunity sales in 2004/05 rather than selling off-peak. Therefore given the total volume of opportunity sales in 2004/05, it is reasonable to assume that the majority of these sales were made during the on-peak period.
