Scope of this Report

The IECs were asked to provide an update on (i) what is going well in the process to date; (ii) are there any concerns; (iii) are the IECs on time and on budget to meet their scope of work.

Some of the IECs have prepared more formal reports, whereas others have forwarded more circumscribed and informal reports. However, in general these reports have addressed in an overall manner the points identified above.

Status of the Round 1 IRs

In addition, I have requested that IECs provide a status report of the Round 1 IRs, to be broken down into the categories:

- (Y): Information Requests which can be formally withdrawn from the public record in accordance with PUB Order 119/13 as a satisfactory response was received from Manitoba Hydro on an informal basis for the IECs' analytic purposes;
- 2. (N): Information Requests which, in accordance with PUB Order 119/13, will remain on the public record at this time as the IEC is not satisfied with the level of response as received from Manitoba Hydro on an informal basis;
- 3. (IF): Information Requests which require further discussion and/or information from Manitoba Hydro on an informal basis before it can be determined if it will be withdrawn in accordance with PUB Order 119/13. Once this information, if received and is satisfactory, it will be formally withdrawn. If a satisfactory response cannot be provided by Manitoba Hydro, it will remain on the public record; and,
- 4. (INV): Information Requests which require the IEC to further review the sufficiency of the response from Manitoba Hydro and more meaningfully review the supporting documentation available before a determination can be made as to whether it will be withdrawn or stay on the public record.

Knights Pieshold

There have been no concerns raised at this point in time and they are proceeding with their scope of work. It is expected that they will be completing their scope of work obligations on time and on budget. A status report on the Round 1 IRs is forthcoming.

POWER Engineers

They are awaiting delivery of the IR responses to begin the main body of their work. At this point, there have been no concerns raised about being able to meet their scope of work obligations on time and on budget. However, the one concern that has been

This is currently being dealt with. A status report on the Round 1 IRs is forthcoming. In addition, a copy of their stand-alone status report will be sent to your attention under separate cover.

Elenchus Research Associates Inc.

There have been no concerns raised with respect to being able to meet their scope of work obligations on time and on budget. Please find attached as Schedule "A" to this letter their report on the status of the Round 1 IRs.

Potomac Economics

The main concern that has been raised pertains to their requesting from Manitoba Hydro for more information regarding the underlying basis for the consultants' price forecasts. This was data underlying the market simulations that were used by the six consultants. Manitoba Hydro advised that they did not have the data and were not sure if they would or could get it from the consultants. Further, Manitoba Hydro advised that they will discuss internally what approach to take in responding to the request. Manitoba Hydro has indicated that they will likely not be able to respond until next week. Without this underlying simulation data, *Potomac* will not able to fully examine the basis of the consultants' forecasts, which will likely adversely affect their ability to complete their scope of work. A status report on the Round 1 IRs is forthcoming.

MNP

There have been no concerns raised with respect to being able to meet their scope of work obligations on time and on budget. Please find attached as Schedule "B" to this letter their report on the status of the Round 1 IRs in conformity with Order 119/13.

TYPLAN Consulting Ltd.

There have been no concerns raised with respect to being able to meet their scope of work obligations on time and on budget. A report on the status of Round IRs is forthcoming.

Morrison Park Advisors

They have indicated that there are several aspects of the initial activity of the NFAT review that have been going well, such as the informal meetings with Manitoba Hydro. However, there have been some concerns related to being able to receive satisfactory information that is responsive to the IRs. This issue is being assessed and

Report on the Status of MNP Round 1 IRs



La Capra Associates (LCA) has reviewed the Round 1 Information Requests (IRs) submitted as part of the NFAT process on September 16, 2013. LCA has met with Manitoba Hydro staff on numerous occasions both in person and via teleconference. LCA has received informal IR responses through these conversations and through documents posted on the Manitoba Hydro SharePoint website. Based on its review of this information, LCA has assessed the sufficiency of these responses and designated each IR as belonging to one of the four categories below. These are the same categories used by MNP in its review of IRs.

- 1. **Y** Information Request can be formally withdrawn from the public record as a satisfactory response was received from Manitoba Hydro on an informal basis for our analytic purposes.
- 2. N Information Request remains on the public record at this time.
- IF Information Request requires further discussion and/or information from Manitoba Hydro on an informal basis before it can be withdrawn. Once this information is received and satisfactory, it will be formally withdrawn. If a satisfactory response cannot be developed by Manitoba Hydro, it will remain on the public record.
- 4. **LCAInv** Information Request requires LCA to further review the sufficiency of the response from Manitoba Hydro and more meaningfully review the supporting documentation available.
