SUPPLEMENTAL FILING OF RESPONSES TO FIRST ROUND INFORMATION REQUESTS

Manitoba Hydro is pleased to advise that it has posted its responses to the following First Round Information Requests (IRs) posed by the PUB and Registered Intervenors:

PUB: 167, 216(a) and (b), 250 (a) and (b), and 266(b);
CAC: 6, 38, 112(b), 126, 223(a) and (b), 239 (b);
CAC/GAC: 3(b), 4(d), 19 (a) and (b), 22(d), 23(a) and (b), 25 (c), and 26;
GAC: 104; and
MIPUG: 41(d).

Responses to PUB 277(a), CAC/GAC 20(a) and (b), and MMF 74(a) and (b) remain outstanding and will be provided by next Friday, November 22.

Manitoba Hydro has also posted its responses to several Information Requests posed by the IECs, including a number from Morrison Park Advisors which were intended to be posted on November 8, but due to technical difficulties were posted on November 12.

Manitoba Hydro has also updated the response to MIPUG/MH-I-007 so that the Excel file referenced is now included. You will also note that Manitoba Hydro has made formatting corrections to a number of information requests which do not change the substantive response, including correction to dates referenced in the footer of some IRs and some bullets which appeared as numbers rather than bullets.

Manitoba Hydro has noted the comments of the PUB with respect to the Information Requests posed by the IECs. At present, Manitoba Hydro is working to file responses to Information Requests which the IECs have identified as requiring formal responses on the public record. Manitoba Hydro continues to meet with IECs to share information as requested, and to address those IR's which IECs have indicated require additional information or time for further review by the IECs with a view to resolving which of those IRs have been satisfied.
