RE: MANITOBA HYDRO NFAT
EXPORT CONTRACTS & TERM SHEETS

In its letter of November 20, 2013 Manitoba Hydro indicated that it would be in a position to file redacted copies of the export contracts underpinning the Preferred Development Plan shortly. By way of background, during the summer and fall of 2013 Manitoba Hydro worked with counterparties to redact and obtain consents to file the export contracts and term sheets in the NFAT. In some cases a public redacted version of the document already existed however pursuant to confidentiality provisions in the contracts, it remained necessary to seek consent to file the contracts and develop redacted versions suitable for public posting.

The following redacted versions of the contracts previously filed as Commercially Sensitive Information have been posted to the NFAT site:

- Wisconsin Public Service and Manitoba Hydro – Term Sheet dated March 2008 and Amending Agreements 1 through 5;
- Northern States Power and Manitoba Hydro 375/325MW System Power Sale Agreement dated May 27, 2010;
- Northern States Power and Manitoba Hydro 350MW Diversity Sale Agreement dated May 27, 2010;
- Northern States Power and Manitoba Hydro 125MW System Power Sale Agreement dated May 27, 2010;
- Wisconsin Public Service and Manitoba Hydro – 100MW System Power Sale Agreement dated May 19, 2011;
- Wisconsin Public Service and Manitoba Hydro – 108MW 2011 Energy Sale Agreement dated May 19, 2011;

- Minnesota Power and Manitoba Hydro Energy Exchange Agreement dated May 19, 2011;
