**THE VILLAGE OF TREHERNE
WATER AND SEWER RATES
BY-LAW NO. 821/00**

WHEREAS the Village of Treherne has applied to The Public Utilities Board for approval of By-law No. 821/00 to revise the schedule of water and rates of the said Village, and after public notice of the application - no persons signifying their desire to make representation in the matter;

AND WHEREAS the Board notes that the utility rate study which accompanied the application provided for a sum of money to be placed in a utility reserve account, and the Board therefore desires to ensure that these moneys be expended in an appropriate fashion;

AND WHEREAS the Board deems it expedient to do so;

IT IS THEREFORE ORDERED THAT:

1. By-law No. 821/00 of the Village of Treherne BE AND THE SAME IS HEREBY APPROVED;

2. The water and sewer rates set forth in Schedule "A" hereto shall apply to all customers of the utility effective on the next billing in the normal course after the date of this Order.
3. This Order is subject to moneys being expended from the utility reserve fund only to support existing infrastructure, unless the Board has authorized the expenditure pursuant to Section 168 of The Municipal and Various Acts Amendment Act, c. 58.

SCHEDULE "A"

SCHEDULE OF QUARTERLY RATES:

1. Commodity rates per M.G.

2. Minimum charges, Quarterly

Notwithstanding the Commodity rates set forth in paragraph 1 hereof, all customers will pay the applicable minimum charges set out below, which will include water allowances indicated:

(a) Water and Sewer Customers

(b) Water Only Customers

Minimum charge will be the same for each meter size as shown, above, but the Sewer Commodity Charge will be excluded.

(c) Sewer only for Residential Customers

The Village of Treherne do charge the owners or occupants of land serviced with sewer but no water the sum of \$10.45 per quarter.

3. Bulk Sales Rate

All water sold in bulk by the Village of Treherne shall be charged for at the rate of \$6.00 per 1,000 gallons on a pro-rated basis for all quantities greater than 500 gallons. for any quantity of 500 gallons or less the minimum charge will be \$3.00.

4. Service to Customers Outside the Village of Treherne Limits

The Council of the Village of Treherne may sign agreements with customers for the provision of water and sewer services to properties located outside the legal boundaries of the Village of Treherne. Such agreements shall provide for payment of the appropriate rates set out in the schedule, as well as a surcharge, set by resolution of Council, which shall be equivalent to the frontage levy, general taxes and special taxes for utility purposes in effect at the time, or may be in effect from time to time, and which would be levied on the property concerned if it were within these boundaries. In addition, all costs of connecting to the utility's mains and installing and maintaining service connections will be paid by the customer.

5. Billings and Penalties

Accounts shall be billed quarterly, and shall be due and payable 30 days after date of billing. A penalty of 10% of the amount of the bill shall be added if not paid by the due date.

6. Disconnection

Service may be disconnected and discontinued immediately and without further notice in the event of non-payment of the account within 30 days after due date.

7. Reconnection

Any service disconnected due to non-payment of account shall not be reconnected until all arrears; penalties and a reconnection fee of \$25.00 have been paid.

8. Outstanding bills

Pursuant to Section 236(1)(b) of The Municipal Act, the amount of all outstanding charges for water and sewer service are a lien and charge upon the land serviced, and shall be collected in the same

manner in which ordinary taxes upon the land are collectible, and with like remedies.

9. Hydrant Rentals

The Village of Treherne will pay to the utility an annual rental of \$75.00 for each hydrant connected to the system.

10. Sewer Surcharges

(a) There will be levied annually, in addition to rates set forth above, a special surcharge on sewage having Biochemical Oxygen demand in excess of 300 parts per million, to be set by resolution of council.

(b) A special surcharge for substances requiring special treatment shall be charged based on the actual costs of treatment required for the particular sewage or industrial wastes.

11. Request to Replace Meter

Any water customer requesting that a water meter be replaced, shall be charged a fee of \$25.00 (twenty-five), refundable if the meter is found to not be in proper working condition.

12. Meter Reading

Every water customer in the Village of Treherne will be responsible for the reading of their own meter, and will be responsible for the reading to be either phoned, mailed or dropped off at the municipal office. The Village of Treherne will only be responsible for reading the water meters when they are conducting an audit.

13. Fee of Reading Meter

Every water customer that fails to either phone, mail or drop off their water meter reading during the appropriate time schedule, will have their meter read by the Village of Treherne Personnel and be charged a \$10.00 fee for this service. If the Village Personnel are unable to access the water meter in an appropriate time frame to take a reading an estimate will be taken and the customer will still be liable for the charge.
