APPENDIX "A"

TO BOARD ORDER NO. 22/01

THE TOWN OF CHURCHILL

WATER AND SEWER RATES

BY-LAW NO. 704/2000

1. Bulk Water Sales

The charge for bulk water sales shall be as set out in Schedule "A" hereto attached;

2. Customer Service Charge

The customer service charge shall be as set out in Schedule "A" hereto attached;

3. Quarterly Rates

The quarterly rates shall be as set out in Schedule "A" hereto attached;

4. Minimum Quarterly Billings

The minimum quarterly billing shall be as set out in Schedule "B" hereto attached;

5. Unmetered Residential Service

The unmetered residential service charge shall be as set out in Schedule "C" hereto attached;

6. Hudson Bay Port Company

In consideration of the fact that the Hudson Bay Port Company does not use the sewage collection or sewage treatment system, the quarterly rate chargeable to the Hudson Bay Port Company shall be as set out in Schedule "D" hereto attached;

7. Billings and Penalties for Non-Payment

Water and sewer bills shall be due and payable within 15 days of the billing date. A penalty of 10% of the total amount owing shall be charged on each bill if the amount is not paid by the due date.

8. Hydrant Rentals

The Town of Churchill shall pay the Utility an annual rental per hydrant for 29 hydrants connected to the system, as set out in Schedule "E" hereto attached;

9. Untreated Raw Water

The rate for untreated raw water shall be as set out in Schedule "F" hereto attached.

10. Disconnection and Reconnection

- (a) Water and sewer services may be disconnected without further notice if the water and sewer accounts have not been paid within 30 days of the due date. A disconnection fee of \$50.00 will be added to the account at this time. Prior to turning the water back on, a further \$50.00 will be added to the amount which must be paid to clear the account;
- (b) In the event that a customer desires to disconnect their water service, a fee of \$50.00 will be instituted and added to the final bill for the service. When the service is turned back on, a further fee of \$50.00 will be charged.
