INITIAL SEWER RATES
AMENDING BOARD ORDER NO. 128/00**

WHEREAS the Rural Municipality of Woodlands serving Local Improvement District No. 3 (Village of Woodlands) applied to The Public Utilities Board (the "Board") for approval of sewer rates;

AND WHEREAS the Board in Order No. 128/00 dated September 19, 2000 approved such rates;

AND WHEREAS the Rural Municipality of Woodlands in a letter dated February 20, 2001 and Resolution No. 638/01 advised the Board that the number of residential equivalent units assessed Woodlands Legion were excessive and applied for revised residential equivalent units from 6 units to 1.5 units;

AND WHEREAS after considering the application and deeming no further notice is required, the Board deems it expedient to do so;

IT IS THEREFORE ORDERED THAT:

By-law No. 2405/99 approved by the Board in Order No. 128/00 be amended by deleting Schedule "A" attached thereto and substituting a revised Schedule "A" as attached to this Order.

1. Quarterly Rates for Sewer Service

2. Billings and Penalties

Accounts shall be billed quarterly, and shall be due and payable 30 days after date of billing. A penalty of 1% of the amount of the bill shall be added if not paid by the due date.

3. Disconnection

Service may be disconnected and discontinued immediately and without further notice in the event of non-payment of the account within 30 days after due date.

4. Reconnection

Any service disconnected due to non-payment of account shall not be reconnected until all arrears, penalties and a reconnection fee of \$50.00 have been paid.

5. Outstanding Bills

Pursuant to Section 236(1)(b) of The Municipal Act, the amount of all outstanding charges for sewer service are a lien and charge upon the land serviced, and shall be collected in the same manner in which ordinary taxes upon the land are collectible, and with like remedies.

6. Sewage Surcharges

- (a) There may be levied annually, in addition to rates set forth above, a special surcharge on sewage having a Biochemical Oxygen demand in excess of 300 parts per million, to be set by resolution of Council.
- (b) A special surcharge for substances requiring special treatment shall be charged based on the actual costs of treatment required for the particular sewage or industrial wastes.
