## 2. Billings and Penalties

Accounts shall be billed quarterly, and shall be due and payable 30 days after date of billing. A penalty of 10% of the amount of the bill shall be added if not paid by the due date.

# 3. Outstanding Bills

Pursuant to Section 236(1) of The Municipal Act, the amount of all outstanding charges for sewer service are a lien and charge upon the land serviced, and shall be collected in the same manner in which ordinary taxes upon the land are collectable, and with like remedies.

- 4. The rates and service charges set forth in the said schedule shall be levied from the date on which any building is connected to a sewer line.
- 5. In the event that more than one business or commercial undertaking of any kind is carried on in any building, a separate charge shall be levied against the owner or proprietor of each business or commercial undertaking whose premises are connected to the sewerage system.
