BY-LAW NO. 2002-11**

**WHEREAS** The Rural Municipality of East St. Paul has applied to The Public Utilities Board for approval of By-law No. 2002-11 to revise the schedule of water rates of the said Municipality, and after public notice of the application - no persons signifying their desire to make representation in the matter;

**AND WHEREAS** the Board deems it expedient to do so;

**IT IS THEREFORE ORDERED THAT:**

1. By-law No. 2002-11 of The Rural Municipality of East St. Paul BE AND THE SAME IS HEREBY APPROVED subject to amendment on second reading to amend Clause 5 as set out in Schedule "A" attached hereto;
2. The water rates set forth in Schedule "A" hereto shall apply to all customers of the utility effective on the next billing in the normal course after the date of this Order.

**SCHEDULE "A"**

**THE RURAL MUNICIPALITY OF EAST ST. PAUL**

**WATER RATES**

**BY-LAW NO. 2002-11**

1. Schedule of Rates:

Semi-Annual Commodity Rates:

Minimum Semi-Annual Charges:

| 15 mm      | 25                 | \$16.75                 | \$ 21.25         | \$ 38.00            |
| 19 mm      | 50                 | \$16.75                 | \$ 42.50         | \$ 59.25            |
| 25 mm      | 100                | \$16.75                 | \$ 85.00         | \$101.75            |
| 38 mm      | 250                | \$16.75                 | \$212.50         | \$229.25            |
| 50 mm      | 750                | \$16.75                 | \$531.25         | \$548.00            |

2. Billings and Penalties:

Accounts shall be billed semi-annually in advance (in January and July of each year) together with any excess charges for metered water service for the preceding six (6) months and shall be due and payable within thirty (30) days of the billing date. A penalty of 1¼% per month shall be added to any unpaid accounts.

3. Multiple Businesses:

If one or more businesses are carried on in a building, then a separate charge will be made for each business.

4. Hydrant Rentals:

The Rural Municipality of East St. Paul will pay the Utility an annual rental of \$50.00 for each hydrant connected to the system. This amount includes the cost of water used for fire fighting.

5. Soccer Complex:

The Rural Municipality of East St. Paul will pay the utility a fee of \$450.00 per year for use of water by the Soccer Complex.

6. Overdue Accounts:

Pursuant to Section 236(1)(b) of The Municipal Act, the amount of all outstanding charges for services are a lien upon that land and shall be collected in the same manner in which ordinary taxes upon land are collectible and with like remedies. Where the tenant is in arrears the property owner should be notified in all cases.

7. Disconnection and Discontinuance of Service:

Services may be disconnected and discontinued without further notice if an account has not been paid within 30 days after the due date. Prior to reconnection, payment shall be made of all arrears and penalties on the account plus a reconnection fee of \$100.00.
