SEWER RATES
BY-LAW #2-2003**

WHEREAS The Village of Crystal City has applied to The Public Utilities Board for approval of By-law #2-2003 to revise the schedule of sewer rates of the said Village, and after public notice of the application - no persons signifying their desire to make representation in the matter;

AND WHEREAS the Board notes that the utility rate study which accompanied the application provided for a sum of money to be placed in a utility reserve account, and the Board therefore desires to ensure that these moneys be expended in an appropriate fashion;

AND WHEREAS the Board deems it expedient to do so;

IT IS THEREFORE ORDERED THAT:

1. By-law #2-2003 of The Village of Crystal City BE AND THE SAME IS HEREBY APPROVED;

2. Billing

That all billings shall be sent out on a semi-annual basis between the first day and the tenth day in each of the months June and December.

3. Outstanding Bills

Pursuant to Section 252(2) of *The Municipal Act*, the amount of all outstanding charges for sewer service are a lien and charge upon the land serviced, and shall be collected in the same manner in which ordinary taxes upon the land are collectible, and with like remedies.

4. Sewer Surcharges

- (a) There will be levied annually, in addition to rates set forth above, a special surcharge on sewage having a Biochemical Oxygen demand in excess of 300 parts per million, to be set by Resolution of Council.
- (b) A special surcharge for substances requiring special treatment shall be charged based on the actual costs of treatment required for the particular sewage or industrial waste.
