**THE RURAL MUNICIPALITY OF ROLAND  
WATER AND SEWER RATES  
BY-LAW NO. 4-2003**

---

**WHEREAS** the Rural Municipality of Roland has applied to The Public Utilities Board for approval of By-law No. 4-2003 to revise the schedule of water and rates of the said Municipality, and after public notice of the application - no persons signifying their desire to make representation in the matter;

**AND WHEREAS** the Board deems it expedient to do so;

**IT IS THEREFORE ORDERED THAT:**

1. By-law No. 4-2003 of the Rural Municipality of Roland BE AND THE SAME IS HEREBY APPROVED subject to amendment on second reading to amend clause 8 as set out in Schedule "A" attached hereto;
2. The water and sewer rates set forth in Schedule "A" hereto shall apply to all customers of the utility effective on the next billing in the normal course after the date of this Order.

3. Pursuant to Subsection 2(6) of The Public Utilities Board Act R.S.M. 1987 p.280 the sewage collection and disposal system in the Rural Municipality of Roland is hereby declared to be a public utility.

SCHEDULE "A"

TO BOARD ORDER NO. 102/03

WATER AND SEWER RATES

BY-LAW NO. 4-2003

SCHEDULE OF QUARTERLY RATES:

1. Commodity rates per M.G.

2. Minimum Charges, Quarterly

Notwithstanding the Commodity rates set forth in paragraph 1 hereof, all customers will pay the applicable minimum charges set out below, which will include water allowances indicated:

(a) Water and Sewer Customers

(b) Water Only Customers

Minimum charge will be the same for each meter size as shown above, but the Sewer Commodity Charge will be excluded.

(c) Sewer Only for Residential Customers

The Rural Municipality of Roland do charge the owners or occupants of land serviced with sewer but no water the sum of \$26.00 per quarter.

3. Bulk Sales Rate

All water sold in bulk by the Rural Municipality of Roland shall be charged for at the rate of \$6.50 per 1,000 gallons.

4. Service to Myrtle Water Board Inc.

All water sold to the Myrtle Water Board of Local Improvement District No. 2 in the Rural Municipality of Roland shall be charged for at the rate of \$6.50 per 1,000 gallons.

5. Service to Customers outside Municipality

The Council of the Rural Municipality of Roland may sign agreements with customers for the provision of water and sewer services to properties located outside the legal boundaries of the Municipality. Such agreements shall provide for payment of the appropriate rates set out in the schedule, as well as a surcharge, set by resolution of Council, which shall be equivalent to the frontage levy, general taxes and special taxes for utility purposes in effect at the time, or may be in effect from time to time, and which would be levied on the property concerned if it were within these boundaries. In addition, all costs of connecting to the utility's mains and installing and maintaining service connections will be paid by the customer.

6. Billings and Penalties

Accounts shall be billed quarterly, and shall be due and payable 30 days after date of billing. A penalty of 10% of the amount of the bill shall be added if not paid by the due date.

7. Disconnection

Service may be disconnected and discontinued immediately and without further notice in the event of non-payment of the account within 30 days after due date.

8. Reconnection

Any service disconnected for any reason shall not be reconnected until all regulations have been complied with, and all arrears, penalties and a reconnection fee of \$15.00 have been paid.

9. Outstanding Bills

Pursuant to Section 252(2) of *The Municipal Act*, the amount of all outstanding charges for water and sewer service are a lien and charge upon the land serviced, and shall be collected in the same manner in which ordinary taxes upon the land are collectible, and with like remedies.

10. Hydrant Rentals

The Rural Municipality of Roland will pay to the utility an annual rental of \$50.00 for each hydrant connected to the system.

11. Water Allowance Due to Line Freezing

That in any case where, at the request of the Council, a customer allows water to run continuously for any period of time to prevent the water lines in the water system from freezing, the charge to that customer for the current quarter shall be the average of the billings for the last two previous quarters to the same customer, or to the same premises if the occupant has changed.

12. Sewage Surcharges

- (a) There may be levied annually, in addition to rates set forth above, a special surcharge on sewage having a Biochemical Oxygen demand in excess of 300 parts per million, to be set by resolution of Council.
- (b) A special surcharge for substances requiring special treatment shall be charged based on the actual costs of treatment required for the particular sewage or industrial wastes.
