INITIAL WATER RATES  
BY-LAW NO. 2003-15**

**WHEREAS** The Rural Municipality of Daly has applied to The Public Utilities Board for approval of By-law No. 2003-15 for establishment of water rates of the said Municipality, and after public notice of the application - no persons signifying their desire to make representation in the matter;

**AND WHEREAS** the Board deems it expedient to do so;

**IT IS THEREFORE ORDERED THAT:**

1. By-law No. 2003-15 of The Rural Municipality of Daly BE AND THE SAME IS HEREBY APPROVED subject to amendment on second reading to agree with Schedule "A" attached hereto;
2. The water rates set forth in Schedule "A" shall apply to all customers of the utility effective on the next billing in the normal course after the date of this Order.

SCHEDULE "A"

TO BOARD ORDER NO. 3/04

THE RURAL MUNICIPALITY OF DALY

INITIAL WATER RATES

BY-LAW NO. 2003-15

**Schedule of Quarterly Rates:**

1. Commodity rates per M.G. (thousand gallons)

	<u>Water</u>
All Water Consumption	\$4.50

2. Minimum Charges Quarterly

Notwithstanding the commodity rates set forth in paragraph 1 hereof, all customers will pay the applicable minimum charges set out below, which will include water allowance indicated:

Water Customers

Meter Size	Group Capacity Ratio	Water Included Gallons	Customer Service Charge	Total Quarterly Minimum
5/8	1	3000	32.00	32.00

3. Billings and Penalties

Accounts shall be billed quarterly, and shall be due and payable 30 days after date of billing. A penalty of 10% of the amount of the bill shall be added if not paid by the due date.

4. Disconnection

Service may be disconnected and discontinued immediately and without further notice in the event of non-payment of the account within 30 days after due date.

5. Reconnection

Any service disconnected due to non-payment of account shall not be reconnected until all arrears, penalties and a reconnection fee of \$50.00 have been paid.

6. Outstanding Bills

Pursuant to Section 252(2) of The Municipal Act, the amount of all outstanding charges for the Water Service is a lien and charge upon the land serviced, and shall be collected in the same manner in which ordinary taxes upon the land are collectable, and with like remedies.

7. Water Allowance Due to Line Freezing

That in any case where, at the request of the Council, a customer allows water to run continuously for any period of time to prevent the water lines in the water system from freezing, the charge to that customer for the current quarter shall be the average of the billings for the last two previous quarters to the same customer, or to the same premises if the occupant has changed.
