## B. Water only

Quarterly charge will be the same as in A. above, for customers with the same number of Units allocated, except that the Sewer Commodity charge will be excluded.

#### 2. Bulk Sales Rate:

All water sold in bulk by the Village of St. Lazare shall be charged for at the rate of ½ (half) a cent per gallon.

## 3. Hydrant rentals:

The Village will pay to the Utility an annual rental of \$75.00 for each hydrant connected to the system.

#### 4. Billing and Penalties:

Accounts shall be billed quarterly, and shall be due and payable 30 days after date of billing. A penalty of 5% of the amount of the bill shall be added if not paid by the due date.

#### 5. Disconnection:

Service may be disconnected and discontinued immediately and without further notice in the event of non-payment of the account within 30 days after due date.

#### 6. Reconnection:

Any Service disconnected due to non-payment of account shall not be reconnected until all arrears, penalties and a reconnection fee of \$25.00 has been paid.

#### 7. Outstanding Bills:

Pursuant to Section 252(2) of The Municipal Act, the amount of all outstanding charges for water and sewer service are a lien and charge upon the land serviced and shall be collected in the same manner in which ordinary taxes upon the land are collectible, and with like remedies.
