- 2. The water and sewer rates set forth in Schedule "A" hereto shall apply to all customers of the utility effective on the next billing in the normal course after the date of this Order;
- 3. This Order is subject to moneys being expended from the utility reserve fund only to support existing infrastructure, unless the Board has authorized the Section 168 of expenditure pursuant to Municipal and Various Acts Amendment Act, c. 58.
