BY-LAW NO. 17-2004

1. Commodity Rates per M.G.

$\$ 5.50 \mathrm{M} . \mathrm{G}$.
2. Minimum Charges (Quarterly)

Notwithstanding the Commodity Rates set forth in paragraph 1 hereof, all customers will pay the applicable minimum charges set out below, which will include allowances as indicated:

3. Billings and Penalties for Non-payment of Account:

All connected customers shall be billed quarterly and payment shall be due within 30 days from the date of billing. A penalty of one and one-quarter percent ( $11 / 4 \%$ ) shall be charged on the dollar amount owing after the billing due date and shall be added and compounded monthly until the bill is paid or added to taxes. A notice to this effect shall be clearly printed on all bills sent to customers.
4. Disconnection and reconnection of service:

If any bill issued pursuant to section 3 hereof is not paid within forty-five (45) days of the billing date, the municipality may disconnect and discontinue service to the customer immediately and without further notice.

If any service is discontinued, pursuant to this clause, such service shall not be reconnected until payment has been made for a reconnection charge of thirty (\$30.00) dollars, plus the amount of any unpaid bills and penalties.
5. Liability for Charges:

Where charges and penalties pursuant to this by-law remain unpaid for a period of 30 days or more after the due date, said charges and penalties shall be added to the taxes on the property and collected in the same manner as other taxes as per authority of Section 252(2) of The Municipal Act of Manitoba.
