BY-LAW NO. 6/05**

**WHEREAS** the Rural Municipality of Thompson serving Local Improvement District No. 1 (Miami) has applied to The Public Utilities Board for approval of By-law No. 6/05 to revise the schedule of water and sewer rates of the said Municipality, and after public notice of the application - no persons signifying their desire to make representation in the matter;

**AND WHEREAS** the Board deems it expedient to do so;

**IT IS THEREFORE ORDERED THAT:**

1. By-law No. 6/05 of The Rural Municipality of Thompson serving Local Improvement District No. 1 (Miami) BE AND THE SAME IS HEREBY APPROVED;
2. The water and sewer rates set forth in Schedule "A" hereto shall apply to all customers of the utility effective on all water consumed and on all minimum bills effective on the next billing in the normal course after the date of this Order.

THE RURAL MUNICIPALITY OF THOMPSON

LOCAL IMPROVEMENT DISTRICT NO. 1 (MIAMI)

WATER AND SEWER RATES

BY-LAW NO. 6/05

1. THAT Schedule "A" of By-law No. 5/01 be amended to increase the water commodity price from \$1.50 per c.m. to \$1.61 per c.m.:

1. Commodity Rates per C.M.

2. Minimum Charges, Quarterly

Notwithstanding the Commodity rates set forth in paragraph 1 hereof, all customers will pay the applicable minimum charges set out below, which will include water allowances indicated:

- (a) Water and Sewer Customers

3. Bulk Sales Rate

All water sold in bulk by the Miami Utilities shall be charged for at the rate of \$7.32 per 1,000 gallons on a pro-rated basis for all quantities greater than 500 gallons. For any quantity of 500 gallons or less the minimum charge will be \$4.15.
