AND WHEREAS the Board deems it expedient to do so;

IT IS THEREFORE ORDERED THAT:

- 1. By-law No. 3/2005 of the Rural Municipality of West St. Paul serving Local Improvement District No. 3 (Lister Rapids) BE AND THE SAME IS HEREBY APPROVED;
- 2. The sewer rates set forth in Schedule "A" hereto shall apply to all customers of the utility effective on all minimum bills effective on the next billing in the normal course after the date of this Order;
- 3. This Order is subject to moneys being expended from the utility reserve fund only to support existing infrastructure, unless the Board has authorized the expenditure pursuant to Section 168 of The Municipal and Various Acts Amendment Act, c. 58.

SEWER RATES

BY-LAW NO. 3/2005

- 1. THAT the sum of three hundred and twenty-five dollars (\$325.00) per year, for maintenance of the sewer system in Lister Rapids be levied against each of the sixty-eight (68) lots connected to the sewer system in L.I.D. No. 3;
- 2. THAT the rates shall become effective January 1st, 2006.
- 3. THAT the rates in the year 2006 and subsequent years, the sewer charges may be included on the tax statements for payment.
