**THE RURAL MUNICIPALITY OF WEST ST. PAUL
LOCAL IMPROVEMENT DISTRICT NO. 1 (RIVERCREST)
WATER AND SEWER RATES
BY-LAW NO. 2/2005**

WHEREAS The Rural Municipality of West St. Paul serving Local Improvement District No. 1 (Rivercrest) has applied to The Public Utilities Board for approval of By-law No. 2/2005 to revise the schedule of water and sewer rates of the said Municipality, and after public notice of the application - no persons signifying their desire to make representation in the matter;

AND WHEREAS the Board notes that the utility rate study which accompanied the application provided for a sum of money to be placed in a utility reserve account, and the Board therefore desires to ensure that these moneys be expended in an appropriate fashion;

AND WHEREAS the Board deems it expedient to do so;

IT IS THEREFORE ORDERED THAT:

1. By-law No. 2/2005 of the Rural Municipality of West St. Paul serving Local Improvement District No. 1 (Rivercrest) BE AND THE SAME IS HEREBY APPROVED subject to amendment of Clause 2 of Schedule "A" to the By-law to read:

"THAT the sum of two hundred and fifteen dollars (\$215.00) per year, for the maintenance of the water system in Rivercrest be levied against each of the sixty-four (64) building lots connected to the water system in L.I.D. No. 1;"

2. The water and sewer rates set forth in Schedule "A" hereto shall apply to all customers of the utility effective on all water consumed and on all minimum bills effective on the next billing in the normal course after the date of this Order;
3. This Order is subject to moneys being expended from the utility reserve fund only to support existing infrastructure, unless the Board has authorized the expenditure pursuant to Section 168 of The Municipal and Various Acts Amendment Act, c. 58.

SCHEDULE "A"

TO BOARD ORDER NO. 146/05

THE RURAL MUNICIPALITY OF WEST ST. PAUL

LOCAL IMPROVEMENT DISTRICT NO. 1 (RIVERCREST)

WATER AND SEWER RATES

BY-LAW NO. 2/2005

1. THAT the sum of two hundred and fifty (\$250.00) per year, for maintenance of the sewer system in Rivercrest be levied against each of the one hundred and forty-two (142) lots connected to the sewer system in L.I.D. No. 1.
2. THAT the sum of two hundred and fifteen dollars (\$215.00) per year, for the maintenance of the water system in Rivercrest be levied against each of the sixty-four (64) building lots connected to the water system in L.I.D. No. 1.
3. THAT the rates shall become effective January 1st, 2006.
4. THAT the rates in the year 2006 and subsequent years, the sewer or sewer and water charges may be included on the tax statements for payment.
