DIESEL GENERATED ELECTRICITY RATES – EFFECTIVE JANUARY 1, 2011:

AN ORDER APPROVING RATES PURSUANT TO BOARD ORDER 134/10

FOR THE COMMUNITIES OF BARREN LANDS FIRST NATION AND BROCHET; NORTHLANDS DENESULINE FIRST NATION (LAC BROCHET); SAYISI DENE FIRST NATION (TADOULE LAKE); AND SHAMATTAWA FIRST NATION (SHAMATTAWA)

WHEREAS

In Order 134/10 the Public Utilities Board (Board) varied the Application of Manitoba Hydro (MH) for rates to be charged in the communities of Barren Lands First Nation and Brochet, Northlands Denesuline First Nation (Lac Brochet); Sayisi Dene First Nation (Tadoule Lake); and Shamattawa First Nation (Shamatttawa) (Diesel Zone) to be effective January 1, 2011, and provided specific directions;

AND WHEREAS

On December 31, 2010 MH filed with the Board revised Rate Tables and other documentation (Rate Filing) consistent with the direction of the Board, seeking the review and approval of the Board;

AND WHEREAS

The Board, on reviewing the said Rate Filing for rates to be charged in the Diesel Zone, finds that the Rate Filing to be in accordance with the Board Directives in Order 134/10;

AND WHEREAS

Board decisions may be appealed in accordance with the provisions of Section 58 of The Public Utilities Board Act, or reviewed in accordance with Section 36 of the Board's Rules of Practice and Procedure (Rules). The Board's Rules may be viewed on the Board's website at www.pub.gov.mb.ca.

IT IS THEREFORE ORDERED THAT:

The Rate Filing of Manitoba Hydro, being in accordance with the directives of Board Order 134/10, and as attached hereto, BE AND IS HEREBY APPROVED for rates to be charged in the Diesel Zone effective January 1, 2011 to and including December 31, 2011.

DIESEL ZONE: PROPOSED RATES EFFECTIVE JANUARY 1, 2011

Residential - Tariff No. 2011-03:

Basic Charge \$6.85

PLUS

First 900 kW.h @ 6.38¢ per kW.h Next 1,100 kW.h @ 6.57¢ per kW.h Balance of kW.h @ 35.00¢ per kW.h

The Residential rate applies to all residential services in the Diesel Communities, provided the service capacity does not exceed 60A, 120/240 V, single phase.

General Service - Tariff No. 2011-40:

Basic Charge \$17.65

PLUS

First 2,000 kW.h @ 6.84¢ per kW.h Balance of kW.h @ 35.00¢ per kW.h

The General Service rate applies to all commercial accounts and non-educational First Nation accounts that are not 100% funded by INAC.

Government and First Nation Education - Tariff No. 2011-41:

Basic Charge \$17.65

PLUS

All kW.h @ 213.00¢ per kW.h

A surcharge of 178.00¢ per kW.h is included in the Government and First Nation Education tariff which applies to all Federal and Provincial departments, Agencies, Crown Corporation accounts and First Nation Education accounts. This in addition to the tail rate of 35¢ per kW.h comprised the total government rate of \$2.13/kW.h.

The First Nation Education rate is applicable to all Diesel First Nation facilities providing instructional services for members of the Diesel First Nations, including schools, teacherages and student residences, and which receive funding in support of the costs of providing instructional services in accord with the March 31, 1998 INAC Capital Facilities and Maintenance and Operation and Maintenance Manual, in respect of funding in support of instructional services.
