RURAL MUNICIPALITY OF STE.ROSE LID No. 1 OF LAURIER WATER AND SEWER UTILITY ACTUAL DEFICIT 2009, 2010, 2011 and 2012

WHEREAS the Public Utilities Board issued Order No. 151/08 on November 7, 2008 requiring all water and/or sewer utilities to report an actual year-end deficit to the Board if the utility:

- 1. had not received prior approval for the deficit from the Board and such deficit either exceeds \$10,000 or represents 5% of the utility's operating budget; or
- 2. had received prior approval for the deficit from the Board and the actual deficit:
 - a. exceeds the previously approved amount by either \$10,000 or 5% of the utility's operating budget; or
 - b. is caused as a result that differs from that upon which said approval was granted;

AND WHEREAS the Rural Municipality of Ste. Rose-LID No. 1-Laurier Water and Sewer Utility (Utility) incurred an operating deficit of \$8,648 at the end of the 2009 operating year, when calculated for regulatory purposes;

AND WHEREAS the Rural Municipality of Ste. Rose-LID No. 1-Laurier Water and Sewer Utility (Utility) incurred an operating deficit of \$13,393 at the end of the 2010 operating year, when calculated for regulatory purposes;

AND WHEREAS the Rural Municipality of Ste. Rose-LID No. 1-Laurier Water and Sewer Utility (Utility) incurred an operating deficit of \$15,046 at the end of the 2011 operating year, when calculated for regulatory purposes;

AND WHEREAS the Rural Municipality of Ste. Rose-LID No. 1-Laurier Water and Sewer Utility (Utility) incurred an operating deficit of \$11,224 at the end of the 2012 operating year, when calculated for regulatory purposes;

AND WHEREAS it is proposed that the reason for said deficit is a result of amortization expenses;

AND WHEREAS it is proposed that the 2009 and 2010 deficits be recovered by a draw-down of \$8,648 and of \$13,393 from the Utility Surplus Fund;

AND WHEREAS it is proposed that the 2011 and 2012 deficits of \$15,046 and \$11,224 be recovered by a rate rider over the next five (5) years in the amount of a \$15 per quarter rate rider charge for each ratepayer.

IT IS THEREFORE ORDERED THAT:

1. The actual 2009 and 2010 operating deficits, when calculated for regulatory purposes, of \$8,648 and of \$13,393 incurred in the Rural Municipality of Ste. Rose-LID No. 1-Laurier Water and Sewer Utility Operations, for the purposes set out herein, is HEREBY APPROVED to be recovered from the Utility Surplus;

The actual 2011 and 2012 operating deficits, when calculated for regulatory purposes, of \$15,046 and \$11,224 incurred in the **Rural Municipality of Ste. Rose-LID No. 1-Laurier** Water and Sewer Utility Operations, for the purposes set out herein, is HEREBY VARIED to be recovered by a rate rider over the next three (3) years in the amount of a \$25 quarterly rate rider charge for each ratepayer.
