AN APPLICATION BY THE ELMWOOD CEMETERY COMPANY TO PASS ACCOUNTS DEALING WITH PERPETUAL CARE FUND OF ELMWOOD CEMETERY

1.0 Background

Recent amendments to the Cemeteries Act ("the Act") have resulted in the responsibility for "passing accounts" with respect to the handling of Perpetual Care Fund, shifting from the Court of Queen's Bench to The Public Utilities Board ("the Board").

The Elmwood Cemetery Company ("Elmwood") made an application to the Board for the Passing of Accounts for the Perpetual Care Fund of the Elmwood Cemetery. Due to a change in ownership effective July 31, 1998, Elmwood filed an application for a five year and seven month period from January 1, 1993 to July 31, 1998. This period slightly exceeds the maximum period set out in Section 31(2) of the Act. In support of this application, Elmwood filed the following information:

- 2. Trust monies currently held by National Trust may now be forwarded to the Winnipeg Foundation Trust accounts.
