1.0.0 EXECUTIVE SUMMARY

This Order amends the Public Utilities Board Order No. 30/16, Schedule "A", as it relates to the timetable for the payday loans review ("Review").

By this Order, the Public Utilities Board ("Board") amends the timetable for the Review in accordance with Schedule A.

2.0.0 BACKGROUND

With the concurrence of all interveners of record, the timetable for the Review has been amended in order to give interveners adequate time to complete their research.

3.0.0 BOARD FINDINGS
