APPLICATION BY MANITOBA PUBLIC INSURANCE FOR AN  
ORDER APPROVING PREMIUMS AND OTHER CHARGES  
REVISED PURSUANT TO BOARD ORDER 151/00

Manitoba Public Insurance (the “Corporation”) applied to The Public Utilities Board (the “Board”) on June 7, 2000 for approval of premiums to be charged with respect to compulsory driver and vehicle insurance (“premiums”) for the fiscal year commencing March 1, 2001 and ending February 28, 2002. Amendments to the application were filed on October 2, 2000 and November 8, 2000. The Board held a public hearing from November 6, 2000 to November 13, 2000.

Board Order 151/00, dated December 4, 2000, approved the application for motor vehicle premiums, subject to a number of alterations. The Corporation was ordered to file a revised schedule of premiums, permit, certificate and transaction fees, and other miscellaneous charges and related supporting information for review and approval by the Board.

On December 21, 2000, in accordance with Board Order 151/00, the Corporation filed revised schedules of premiums, attached hereto as Attachments 1 to 5, inclusive. The Board has reviewed the Corporation’s filing and is satisfied that the revised schedules submitted by the Corporation meet the requirements of Board Order 151/00. Accordingly, the Board will approve the Corporation’s filed schedules of December 21, 2000 to be charged from March 1, 2001 to February 28, 2002.

**IT IS THEREFORE ORDERED THAT:**

1. The revised schedules of premiums, permit, certificate and transaction fees, and other miscellaneous charges filed by Manitoba Public Insurance in accordance with Board Order 151/00 and attached hereto as Attachments 1, 2, 3, 4A, 4B and 5 **BE AND ARE HEREBY APPROVED** and are to be charged from March 1, 2001 to February 28, 2002.
