Introduction

By this Order, the Public Utilities Board (Board) approves the Coalition of Manitoba Motorcycle Groups Inc.'s (CMMG) application for a cost award of \$21,685.03, as related to a recently concluded Board hearing of Manitoba Public Insurance's (MPI) proposed 2010/11 Compulsory Driver and Vehicle Insurance Premiums.

Application

The Board held a public hearing of MPI's application at the Board's offices in Winnipeg in October 2009. Several interested parties, including CMMG, intervened in the proceeding.

Pursuant to Section 56 of *The Public Utilities Board Act*, the Board has jurisdiction to award costs of, and incidental to, any proceeding. The Board's Rules of Practice and Procedure (Rules) stipulate four main criteria assisting it in determining whether costs should be awarded to an Intervener. The Notice of Public Hearing for MPI's application advised as to the Board's cost award guidelines.

Pursuant to the Board's Rules and following the hearing, the CMMG applied for an award of costs in the amount of \$21,685.03:

Disbursements (including GST) 115.50

Total Claim \$21,685.03

MPI advised of no objections with respect to CMMG's request.

BOARD FINDINGS

The Board is satisfied with CMMG's participation in and contribution to the proceeding and finds that CMMG qualifies for an award of costs.

CMMG meets the Board's criteria for a cost award and provided a contribution to the Board's understanding of the matters placed before it. As well, CMMG acted cooperatively with the other parties through the proceeding, and provided a concise argument at the conclusion of the hearing.

Accordingly, the Board will grant CMMG's request for costs as claimed.

Board decisions may be appealed in accordance with the provisions of Section 58 of *The Public Utilities Board Act*, or reviewed in accordance with Section 36 of the Board's Rules of Practice and Procedure (Rules). The Board's Rules may be viewed on the Board's website at www.pub.gov.mb.ca.

IT IS THEREFORE ORDERED THAT:

- The Coalition of Manitoba Motorcycle Groups Inc. BE AND IS HEREBY awarded costs of \$21,685.03 with respect to its intervention at the Manitoba Public Insurance Corporation's 2010/11 Compulsory Driver and Vehicle Insurance Premiums hearing.
- 2. Costs shall be payable by the Manitoba Public Insurance Corporation within 30 days of the date of this Order.
