MPI says payouts rose, requests 2% rate hike

MPI says it's been an "unprecedented year" for non-collision payouts.

Manitoba Public Insurance says it needs to raise basic vehicle insurance rates after an "unprecedented year" for non-collision claims payouts.

On Friday, it submitted an application to the Public Utilities Board that rates rise two per cent next year.

MPI says if its application is approved, the average passenger vehicle owner would pay an additional \$17 a year in premium.

Manitoba Public Insurance announced Friday it has asked the Public Utilities Board for a 2% increase to basic Autopac rates. If approved, the Crown corporation said the increase means the average owner of a passenger vehicle would pay about \$17 more per year.

MPI has also asked the PUB to approve an interest rate forecast risk factor, the purpose of which would be to “mitigate the risk of a significant premium increase in the future” due to underperforming interests rates versus the forecasts put out by Canadian banks. ¹

Manitoba Public Insurance seeks 2% basic auto rate increase after “unprecedented” claims payouts

Manitoba Public Insurance (MPI) said on Friday that it has asked the Public Utilities Board for a 2% increase to Basic Autopac rates, citing an “unprecedented” year for comprehensive (non-collision) claims payouts.

In addition to an overall 2% increase in Basic Autopac rates for 2017, MPI has requested that the Public Utilities Board consider introducing an Interest Rate Forecast Risk Factor, effective March 1, 2017, the form and magnitude of which would be developed through a collaborative process with the board and intervenors. “The purpose of the risk factor would be to mitigate the risk of a significant premium increase in the future, due to year-over-year underperformance of interest rates against the forecasts established by the major Canadian banks, and which has an ongoing effect on the corporation’s ability to achieve investment income forecasts.”²

MANITOBA – Your auto insurance rates could be going up.

Manitoba Public Insurance has applied for an overall 2 per cent increase. That would see most drivers pay about 17 dollars more in basic premiums.

It still needs to be approved by the public utilities board.

MPI says last year was “unprecedented” in terms of claims. They say there was a 68 per cent spike in claims costs and hail claims in particular more than tripled from the year before.
