



# News Release

January 23, 2012

In Order No. 8/12 dated January 23, 2012 the Public Utilities Board (Board) approved revised water and sewer utility rates for The City of Selkirk (City) for the years 2012 and 2013, and confirms as final the rates for 2011 approved on an interim basis in order number 53/11, issued on April 4, 2011.
