

## NOTICE OF APPLICATION

January 26, 2012

The Municipality of Shoal Lake (RM) has applied to the Public Utilities Board (Board) for revised water rates for 2012, 2013 and 2014 as set out in By-law No. 11-2011 read the first time on December 1, 2011. The existing rates were approved in 1998 and 2000.
