On August 26, 2014, the Board granted interim approval of the above rates in Board Order No. 95/14 effective August 1, 2014. These interim rates are subject to change pending the Board's full review of the application.

Details of the RM's application are available for review at the RM of Cornwallis' office or the Public Utilities Board's office. Questions concerning the application for water rates, or the operation of the Utility, should be addressed to the RM of Cornwallis.

The Public Utilities Board is the provincial regulatory agency that reviews and approves rates for municipal water and sewer utilities. The Board's review process involves:

- the Utility filing a rate application to the Board,
- the public notification of proposed rate changes,
- the Board's review of the application through a public hearing or paper review process, and
- the issuance of a Board Order which outlines the Board's decision on the rate application and the rates to be charged.
