

NOTICE OF INTERIM RATES The Rural Municipality of Elton

May 28, 2012

The Rural Municipality of Elton (RM) has applied to the Public Utilities Board (Board) for revised water and sewer rates as set out in By-law No. 1423 read the first time on April 12, 2011. By Order No. 28/11 issued February 18, 2011, the Board approved interim water rates which were set on an ex parte basis for 2011 pending submission of a detailed rate study and complete review of the application. Sewer rates were last revised in 2008.

By Order No. 66/12 released May 25, 2012, the Board has now granted a further interim rate change, on an ex parte basis, for 2012 and 2013.

The current and revised commodity rates are noted below:

Current water only rates are \$8.25 per 1,000 gallons, and the quarterly service charge is \$8.85. Sewer charges are levied on a flat rate basis with the average household being assessed \$16 per quarter plus a \$7 service charge.

Details of the RM's application are available for review at the RM's office or the Public Utilities Board's Office. Questions concerning the application for revised rates or the operation of the Utility should be addressed to the RM.

The Public Utilities Board is the provincial regulatory agency that reviews and approves rates for municipal water and sewer utilities.

The Board will then decide whether any further notice and/ or an oral hearing is required. All concerns received by the Board will be considered in the Board's decision on rates to be charged.

PLEASE BE ADVISED THAT IN CONSIDERING THIS APPLICATION, THE PUBLIC UTILITIES BOARD MAY OR MAY NOT FIND IT NECESSARY TO DETERMINE RATES DIFFERENT FROM THOSE APPLIED FOR BY THE APPLICANT.
