**NOTICE OF APPLICATION  
 REVISED WATER and SEWER RATES  
 TOWN OF MINNEDOSA  
 Revised from November 4, 2014**

The Town of Minnedosa (Town) has applied to the Public Utilities Board (Board) for revised rates for the Water and Sewer Utility for 2015 as set out in By-law No. 2538, read the first time on September 23, 2014.

The current rates and proposed rates are provided:

The Public Utilities Board is the provincial regulatory agency that reviews and approves rates for municipal water and sewer utilities. The Board's review process involves:

- the Utility filing a rate application to the Board,
- the public notification of proposed rate changes,
- the Board's review of the application through a public hearing or paper review process, and
- the issuance of a Board Order which outlines the Board's decision on the rate application and the rates to be charged.

The Board will then decide whether any further notice is required and whether to proceed with a public hearing or paper review process. All concerns received by the Board will be considered in the Board's decision on rates to be charged.
