



NOTICE OF APPLICATION
REVISED WATER and SEWER RATES
RURAL MUNICIPALITY of PORTAGE LA PRAIRIE
LUD of OAKVILLE

November 18, 2014

The Rural Municipality of Portage la Prairie (RM) has applied to the Public Utilities Board (Board) for revised rates for the Local Urban District of Oakville Water and Sewer Utility (LUD) for 2015 as set out in By-law No. 3097 read the first time on October 14, 2014. Rates were last set in 2008 in Board Order No. 145/07.

The current rates and proposed rates are provided:

Details of the RM's application are available for review at the RM of Portage la Prairie's office or the Public Utilities Board's office. Questions concerning the application for revised rates, or the operation of the Utility, should be addressed to the RM of Portage la Prairie.

The Public Utilities Board is the provincial regulatory agency that reviews and approves rates for municipal water and sewer utilities. The Board's review process involves:

- the Utility filing a rate application to the Board,
- the public notification of proposed rate changes,
- the Board's review of the application through a public hearing or paper review process, and
- the issuance of a Board Order which outlines the Board's decision on the rate application and the rates to be charged.

The Board will then decide whether any further notice is required and whether to proceed with a public hearing or paper review process. All concerns received by the Board will be considered in the Board's decision on rates to be charged.
