



NOTICE OF APPLICATION

The Town of Neepawa (Town) has applied to the Public Utilities Board (Board) for revised water and sewer rates for 2012, 2013 and 2014 as set out in By-law No. 3098, read the first time on December 20, 2011. The previous rates were last established in 2008 for 2009, 2010 and 2011.
