## NOTICE OF APPLICATION FOR REVISED RATES

By the RM of Victoria-Holland Water and Sewer Utility

June 21, 2012

The Rural Municipality of Victoria (RM) has applied to The Public Utilities Board (Board) for revised rates for the water and sewer services for 2012, 2013 and 2014 as set out in By-law No. 1343/2012 read the first time on February 27, 2012. Rates were last amended in Bylaw 1292/07 which included rates up until 2010. The proposed rate increases were requested to be effective July 1 in each of the years proposed.

The current and proposed rates are noted below:

The Public Utilities Board is the provincial regulatory agency that reviews and approves rates for municipal water and sewer utilities. The Board's review process involves:

- the Utility filing a rate application to the Board
- the Public notification of proposed rate changes
- the Board's review of the application through a public hearing or paper review process
- the issuance of a Board Order which outlines the Board's decision on the rate application and the rates to be charged
