

**NOTICE OF APPLICATION FOR REVISED RATES**  
 By The Local Government District of Pinawa

August 9, 2012

The Local Government District of Pinawa has applied to the Public Utilities Board for rates for water and sewer services for 2012-2016 as set out in By-law No.747-12 read the first time on April 3<sup>rd</sup>, 2012. With the installation of water meters in the community, customers will be charged based on their water consumption. Water and Sewer costs are currently recovered on municipal taxes. As a result of significant response from Pinawa customers, the Board will convene a Public Hearing.

A Public Hearing will be held:

Doors open at **6:30 pm**. Meeting to begin at **7:00 pm**.

The proposed rates are as follows:

	<b>Proposed Rates for 2012-2016</b>
Quarterly Service Charge	\$5.70
Water/m <sup>3</sup>	\$2.40
Sewer/m <sup>3</sup>	\$0.55
Minimum Quarterly Charge*	\$45.94
Reconnection Fee	\$25.00
Hydrant Rental (Annual)	\$100.00

\*For an average two person dwelling using 36 cubic meters of water per quarter, the proposed quarterly bill in 2013 would be approximately \$113.00.
