

# NOTICE OF APPLICATION REVISED WATER and SEWER RATES CITY OF SELKIRK

August 26, 2013

The City of Selkirk (City) has applied to the Public Utilities Board (Board) for revised rates for the water and sewer Utility for 2014, 2015 and 2016 as set out in By-law No. 5252 read the first time on July 29, 2013.



Details of the City's application are available for review at the City of Selkirk's office or the Public Utilities Board's office. Questions concerning the application for revised rates, or the operation of the Utility, should be addressed to the City of Selkirk.

The Public Utilities Board is the provincial regulatory agency that reviews and approves rates for municipal water and sewer utilities. The Board's review process involves:

- the Utility filing a rate application to the Board,
- the public notification of proposed rate changes,
- the Board's review of the application through a public hearing or paper review process, and
- the issuance of a Board Order which outlines the Board's decision on the rate application and the rates to be charged.

Any person who has concerns regarding the City of Selkirk's application for revised rates should either write to:

The Board will then decide whether any further notice is required and whether to proceed with a public hearing or paper review process. All concerns received by the Board will be considered in the Board's decision on rates to be charged.
