

NOTICE OF APPLICATION

March 5, 2012

The Town of Rivers (Town) has applied to the Public Utilities Board (Board) for revised water rates for 2012 as set out in By-law No. 02-2012 read the first time on February 7, 2012. The existing rates were approved in 2002.

The current and the proposed commodity rates are noted below:
