



NOTICE OF APPLICATION REVISED WATER RATES RURAL MUNICIPALITY OF KELSEY CARROT VALLEY AREA

The Rural Municipality of Kelsey (RM) has applied to the Public Utilities Board (Board) for revised water rates as set out in By-law No.04-2015 read the first time on April 16, 2015. Rates were previously set in 2001.

Details of the RM's application are available for review at the Rural Municipality of Kelsey's office or the Public Utilities Board's office. Questions concerning the application for revised rates, or the operation of the Utility, should be addressed to the Rural Municipality of Kelsey.

The Public Utilities Board is the provincial regulatory agency that reviews and approves rates for municipal water and sewer utilities. The Board's review process involves:

- the Utility filing a rate application to the Board,
- the public notification of proposed rate changes,
- the Board's review of the application through a public hearing or paper review process, and
- the issuance of a Board Order which outlines the Board's decision on the rate application and the rates to be charged.

Any person who has concerns regarding the Rural Municipality of Kelsey's application for revised rates should either write to:

The Board will then decide whether any further notice is required and whether to proceed with a public hearing or paper review process. All concerns received by the Board will be considered in the Board's decision on rates to be charged.

PLEASE BE ADVISED THAT IN CONSIDERING THIS APPLICATION, THE PUBLIC UTILITIES BOARD MAY OR MAY NOT FIND IT NECESSARY TO DETERMINE RATES DIFFERENT FROM THOSE APPLIED FOR BY THE APPLICANT.
