**NOTICE OF APPLICATION  
 REVISED WATER and SEWER RATES  
 TOWN of SNOW LAKE**

August 15, 2013

The Town of Snow Lake (Town) has applied to the Public Utilities Board (Board) for revised water and sewer rates effective January 1, 2014 as set out in By-law No.923/13 read the first time on July 16, 2013.

The current rates and proposed rates are provided:

The Public Utilities Board is the provincial regulatory agency that reviews and approves rates for municipal water and sewer utilities. The Board's review process involves:

- the Utility filing a rate application to the Board,
- the public notification of proposed rate changes,
- the Board's review of the application through a public hearing or paper review process, and
- the issuance of a Board Order which outlines the Board's decision on the rate application and the rates to be charged.
