

NOTICE OF APPLICATION

March 7, 2012

The Rural Municipality of Rockwood (RM) has applied to the Public Utilities Board (Board) to combine the water and sewer utility system for Stony Mountain and Bristol into one utility and to approve revised rates for the water and sewer utility for 2012, 2013 and 2014 as set out in By-law No. 04/12 read the first time on January 25, 2012. The rates for the current Stony Mountain Utility were last set in 2003 and those for the Bristol Utility, in 1995.

The proposed commodity rates for the combined utility with comparison to the current rates for the existing Stony Mountain Utility are noted below:

Currently, customers serviced by the Bristol Water distribution system are charged a flat rate of \$50 semi-annually, or \$100 annually. This should be compared to the proposed Water Only – Flat Rate Customers (annual) charges.
