RE: CENTRA GAS MANITOBA INC. ("CENTRA") 2019/20 GENERAL RATE APPLICATION – RESPONSES TO SECOND ROUND INFORMATION REQUESTS AND ADDITIONAL FILINGS

Enclosed are Centra's responses to a portion of Second Round Information Requests ("IR") of the Public Utilities Board ("PUB"), the Consumers Association of Canada (Manitoba), and the Industrial Gas Users, with respect to Centra's 2019/20 General Rate Application ("Application").

Centra anticipates filing the remaining IR responses on or before Friday, June 14, 2019, in accordance with the direction of the PUB contained within its letter of June 4, 2019.

In accordance with the PUB's ruling in its letter of February 26, 2019, Centra is filing responses to Information Requests containing commercially sensitive information with the PUB in confidence and has enclosed public redacted versions. Throughout the Information Request responses, commercially sensitive information has been redacted and Centra has inserted codes corresponding to the Redaction Criteria Centra has consistently used in this Application. Consistent with the original Application, Centra has not provided redaction codes for IRs related to Tab 9 materials as these are filed in confidence in their entirety.

In addition, please also find enclosed revised versions of Centra's responses to two Round I Information Requests.

 PUB/Centra I-7 was revised as the variance explanation for depreciation and amortization expense as originally filed did not correctly characterize the gas SCADA related difference between the 2013/14 approved vs 2013/14 actual and the 2013/14 approved vs 2014/15 actual depreciation expense.  PUB/Centra I-20a-d was revised as the property tax amount for 360 Portage Ave Expenditures table in Part a) inadvertently included an amount for 820 Taylor, which has now been removed. The 2017/18 actual expenditures as well as the cost per square foot have been restated.
