RE: MANITOBA HYDRO'S 2023/24 & 2024/25 GENERAL RATE APPLICATION – AMENDED APPLICATION MATERIALS AND MINIMUM FILING REQUIREMENTS

On November 15, 2022, Manitoba Hydro filed its 2023/24 & 2024/25 General Rate Application ("Application") with the Public Utilities Board of Manitoba ("PUB") requesting confirmation of the 3.6% interim rate increase approved effective January 1, 2022, and approval of a 3.5% rate increase effective September 1, 2023, and approval of a further rate increase of 3.5% increase effective April 1, 2024.

In accordance with Manitoba Hydro's letter dated November 29, 2022 and further information provided at the Pre-Hearing Conference held on Monday, December 5, 2022, Manitoba Hydro is amending portions of its Application, reflecting the impact of the announcement from the Manitoba Government on reduced Provincial Debt Guarantee and water rental fees effective April 1, 2022. The reduced payments have a material impact on Manitoba Hydro's finances and have allowed the utility to reduce the proposed rate increase in each of the 2023/24 and 2024/25 to a 2.0% rate increase in each of these years. Manitoba Hydro is providing a comparison of the Amended Financial Forecast Scenario to the November 15, 2022 Financial Forecast Scenario as Appendix 4.1.1 of the Application.

Manitoba Hydro is enclosing the amended Application materials, which are also publicly available on Manitoba Hydro's website. Attachment 1 to this letter details the Tabs, Appendices and Minimum Filing Requirements that have been amended.

## **Revised Appendix 7.7**

Manitoba Hydro is also revising Appendix 7.7 (Capital Expenditure Plan) as part of this filing. This appendix includes a listing of projects and programs with a total value greater than \$1 million for the test years and totals for 10 and 20 year time periods by investment category. The original filing included only those projects and programs over \$1 million with spending in 2023/24 and has now been updated to include all programs and projects over \$1 million.
