Rationale for Question:

To obtain a clearer understanding of MPI's risk appetite and risk mitigation strategy to protect the policyholders from unintended rate impacting events.

RESPONSE:

a) The risk appetite statement includes the 8 risks from the MPI's risk universe. These risks may impair MPI's ability to achieve its mission and carrying out its strategic plan. The Top 7 corporate risks are based on the risk categories included in its ERM/ORM risk taxonomy. The reconciliation is depicted in the following table.
