# 1.0 Executive Summary

By this Order, the Manitoba Public Utilities Board (Board) grants approval for the Rural Municipality of Hanover (RM), New Bothwell Utility's (Utility) application for revised wastewater rates.

The revised rates are below:

# 2.0 Background

Rates were last set in Board Order No. 151/04, with current rates coming into effect January 1, 2006. Rates were last reviewed and found to be adequate in 2018.

#### **Wastewater Collection and Treatment**

The Utility provides wastewater service to 211 customers. The RM advises that the number of Residential Equivalency Units (REUs) assigned is 221. One REU is the estimate of the volume of wastewater produced by the average single-family residence. The Utility allocates units to non-residential customers based on estimated consumption, as compared with a residence. REUs are used in communities with unmetered distribution and collection systems, where information regarding actual consumption is unavailable.

## 3.0 Board Methodology

#### **Review Process**

When reviewing an application, the Board has at its disposal two approaches, a paper review process or a public hearing. After the publication of the Notice of Application, the Board considers the application and responses, if any, and determines which method of review is most appropriate. Whenever reasonable, the Board can review the application using a paper review process, which saves the cost of a public hearing.

Where there is an urgent need for initial or revised rates and the Board determines it to be in the best interest of all parties, the Board may establish interim *ex parte* rates.





### Interim ex parte Approval

Interim *ex parte* rates are typically approved as applied for and are then subject to a standard Board review process, including a Public Notice of Application, before being confirmed as final by Board Order.

Since this process allows a municipality to charge ratepayers revised rates in advance of the Board's comprehensive review, it is reserved for instances where a municipality can show a compelling argument to allow it.

### **Contingency Allowance and Utility Reserves**

The Board's Water and Wastewater Rate Application Guidelines recommend an annual contingency allowance equal to 10% of the variable operating costs.

### **Working Capital**

Board Order No. 93/09 established utilities should maintain a minimum working capital surplus, in an amount equal to 20% of annual expenses. The working capital surplus is the Utility fund balance, excluding any capital-related items plus Utility reserves.

# **Operating Deficits**

By law, Manitoba utilities are not allowed to incur deficits. In the event that a deficit does occur, the Utility is required by *The Municipal Act* to obtain Board approval for both the deficit and recovery methodology. The Board is therefore duty bound to approve reasonable rates based on reasonable expense projections.

# **Cost Allocation Methodology**

The Board requires all municipalities to review the costs shared between the general operations of the municipality and the Utility, and to allocate appropriate and reasonable costs to the Utility, based on a policy known as a Cost Allocation Methodology. This policy must be submitted to the Board for approval and cannot be changed without





approval by the Board. The Board's requirements regarding cost allocation methodologies can be found in Board Order No. 93/09.

## 4.0 Application

On May 17, 2021, the Board received the RM's application for revised wastewater rates. The application was accompanied by a rate study completed by the RM's consultant and By-law 2509-21, read for the first time on May 12, 2021.

The Board issued a Public Notice of Application on June 8, 2021 affording customers the opportunity to comment to both the Board and the RM with respect to the proposed rate changes. The Board did not receive any responses to the Notice.

The application included the following revenue requirement projections:

The revenue requirements provided by the Utility are for four years of proposed rates and two years provided for information purposes only, to demonstrate the impact of debt maturity. The projections show a negative value for the first five years, indicating current





rates are sufficient to meet the revenue requirements and expected to produce a surplus for the Utility. The rate study advises the Utility is heavily reliant on the tax supported debt payments for the utility, as well as "Other Income". The utility debenture, with current annual payments of \$87,203, will mature in 2026. In 2027, the Utility will be without this revenue stream and will require a large rate increase for 2027 and on, or will experience a large operating deficit.

The "Other Income" included in the projections is revenue from charging industrial overstrength wastewater revenue from its largest industrial customer, Bothwell Cheese. The Utility has experienced significant decreases in this revenue in recent years.

The RM has proposed a phased in approach to increasing utility rates to accommodate the large increase required in 2027.

## **Contingency Allowance and Utility Reserves**

The RM has included in the revenue requirements a contingency allowance of 10% of net rate requirements, less amortization expenses. This equates to \$2,592 for wastewater. There is no provision for transfer to Utility Reserve proposed.

# **Working Capital**

As per the 2020 audited financial statements, the working capital surplus at December 31, 2020 was:

### **Operating Deficits**

The RM has advised the Utility has not experienced any operating deficits in it the past five years.

### **Cost Allocation Methodology**

The Board approved the Utility's current Cost Allocation Methodology (CAM) in Board Order No. 98/17. The RM did not propose any changes to the existing CAM.

## 5.0 Board Findings

The Board has reviewed the application and revenue projections presented by the RM.

The Board has carefully considered the possible consequences of approving or denying the RM's request to phase in wastewater rates over the next four years, despite experiencing annual surpluses. The Board makes the decision to allow the Utility to introduce rate increases for several reasons.

The Board agrees with the reasoning put forth by the RM for slowly increasing the wastewater rates to mitigate rate shock in 2027, after the utility debenture matures. Ratepayers are generally more tolerant of regular, smaller increases. The Board has advocated for municipalities to be mindful of the level of revenue from property tax and to prepare for debenture maturity, where that revenue represents a significant portion of operating costs. In addition, there were no responses to the Notice of Application, which the Board considers an indicator that ratepayers are supportive of the proposal.

Generally, the Board does not approve retroactive rate increases, as they do not allow ratepayers to mitigate the increases by adjusting their consumption. In the case of the New Bothwell Wastewater Utility Point, the rates are set on a flat rate, not by consumption and the 2022 utility bills have not yet been prepared by the RM. The Board will grant approval of the rates proposed by the Utility.





The Board directs the RM to review its wastewater rates for adequacy and file a report with the Board, as well as an application for revised rates if required, by no later than March 31, 2026.

The Board reminds the RM regular reviews are important for a financially sound utility and encourages the RM to review Board Order No. 86/17 for future rate applications. The Order outlines the Simplified Rate Application Process for municipally owned public utilities. If, after its rate review, the RM finds it meets the designated criteria for a simplified rate application, it should apply for future rates using the Simplified Rate Application Process.

#### 6.0 IT IS THEREFORE ORDERED THAT:

- 1. The wastewater rates for the Rural Municipality of Hanover New Bothwell Wastewater Utility, BE AND ARE HEREBY APPROVED in accordance with the attached Schedule A, effective January 1, 2022, 2023, 2024 and 2025.
- 2. The Rural Municipality of Hanover amend its New Bothwell Utility rate By-law to reflect the decisions in this Order, and submit a copy to the Public Utilities Board once it has received third and final reading.
- 3. The Rural Municipality of Hanover is to provide a notice to its customers including the decisions found in this Order, in the annual utility billing, providing a copy to the Public Utilities Board.
- 4. The Rural Municipality of Hanover review the New Bothwell Wastewater Utility rates for adequacy and file a report with the Public Utilities Board, as well as an application for revised rates (if applicable), on or before March 31, 2026.





Fees payable upon this Order - \$500.00

Board decisions may be appealed in accordance with the provisions of Section 58 of *The Public Utilities Board Act*, or reviewed in accordance with Section 36 of the Board's Rules of Practice and Procedure. The following clauses take effect January 1, 2022:

### Service to Customers Outside L.I.D. of New Bothwell Limits

The Council of Rural Municipality of Hanover may sign Agreements with customers for the provision of wastewater services to properties located outside the boundaries of the Local Improvement District of New Bothwell. Such Agreements shall provide for payment of the appropriate rates set out in the Schedule, as well as a surcharge, set by Resolution of Council, which shall be equivalent to the frontage levy, general taxes, and special taxes for the Utility purposes in effect at the time or may be in effect from time to time, and which would be levied on the property concerned if it were within L.I.D. of New Bothwell boundaries. In addition, all costs of connecting to the Utility's mains, and installing and maintaining service connections, will be paid by the customer.

#### **Billings and Penalties**

Accounts shall be billed annually. A late payment penalty charge of 1 ½% compounded monthly shall be charged on the dollar amount owing after the billing due date. The due date will be at least fourteen {14} days after the mailing of the bills.

#### Disconnection

The Public Utilities Board has approved the Conditions Precedent to be followed by the RM with respect to disconnection of service for non-payment including such matters as notice and the right to appeal such action to The Public Utilities Board. A copy of the conditions precedent is available for inspection at the RM's office.

#### Reconnection

Any service disconnected due to non-payment of account shall not be reconnected until all arrears, penalties, and a reconnection fee of \$50.00 have been paid.

#### **Liability for Charges**

Pursuant to Section 252 (2) of the Municipal Act, the amount of all outstanding charges for Wastewater services, including fines and penalties, are a lien and charge upon the land serviced, and may be collected in the same manner in which ordinary taxes upon the land are collectible, and with like remedies.

#### **Wastewater Surcharges**

There may be levied annually, in addition to the rates set forth above, a special surcharge on wastewater having a Biochemical Oxygen Demand in excess of 300 parts per million, to be set by Resolution of Council.

A special surcharge for substances requiring special treatment shall be charged based on the actual costs of treatment required for the particular wastewater or industrial waste.
