## 1.0 Introduction

By this Order, the Public Utilities Board (Board) approves the Taxi Coalition (TC) Application for a cost award of \$108,309.83.

The award relates to TC's intervention in the General Rate Application (GRA) of Manitoba Public Insurance (MPI) with respect to Compulsory Driver and Vehicle Insurance Premiums for the 2024/25 rate year and the Review and Vary Application (R&V) of MPI with respect to PUB Board Order No. 145/23.

## 2.0 Application

On January 24, 2024, the Taxi Coalition filed with the Board an Application for an Award of Costs for its intervention in the Manitoba Public Insurance 2024/25 General Rate Application. On February 26, 2024, a revised application was filed, updated to include an addition of 3.8 hours of time for review of the R&V.

Pursuant to Section 56 of *The Public Utilities Board Act*, the Board has jurisdiction to award costs of, and incidental to, any proceeding before the Board. For the purpose of this hearing, the Board adopted an Intervener Costs Policy. The purpose of this Policy was to set out the Board's procedures for considering requests for Intervener costs and to provide guidance to Interveners on how to apply for funding of costs for participation in Board Proceedings.

Sections 3.1 and 3.2 of the Intervener Costs Policy describes Intervener eligibility for a cost award and the Board's principles in determining the amount of the cost award:

3.1 *In any proceeding the Board may award costs to be paid to any Intervener who has:*

- (a) *made a significant contribution that is relevant to the proceeding and contributed to a better understanding, by all parties, of the issues before the Board;*
- (b) *participated in the hearing in a responsible manner and cooperated with other Interveners who have common objectives in the outcome of the proceedings in order to avoid a duplication of intervention;*
- (c) *represented interests beyond their sole business interest; and*
- (d) *a substantial interest in the outcome of the proceeding and represents the interests of a substantial number of ratepayers.*

*3.2 In determining whether the Intervener should receive the amount of costs sought in a costs application, the Board may consider whether the Intervener did one or more of the following:*

- (a) *made reasonable efforts to ensure that the intervener's evidence was not unduly repetitive of evidence presented by another intervener;*
- (b) *made reasonable efforts to cooperate with other interveners to reduce the duplication of evidence and questions or to combine the intervener's submission with that of similarly interested interveners; and*
- (c) *needed legal or technical assistance to take part in the proceeding;*

In June 2023, TC filed an Application for Intervener status with the Board. The Board awarded TC Intervener status on July 5, 2023 in Board Order 77/23. Included in the Board's Order was an issues list deemed by the Board as applicable to all parties for this proceeding.

On June 23, 2023 TC filed an initial budget with the Board. On August 3, 2023, TC filed an amended projected budget with the Board. Board staff acknowledged receipt of the budgets.

On February 26, 2024, TC filed its final Cost Application for its participation in Manitoba Public Insurance's 2024/25 General Rate Application and R&V. The Cost Application was supported by statements of accounts as summarized below:

TC's Cost Application was supported by detailed invoices and a written submission describing TC's participation.

### 3.0 Manitoba Public Insurance's Comments

On February 1, 2024 and March 1, 2024, Manitoba Public Insurance provided its comments regarding TC's CRA and R&V Cost Applications. MPI did not oppose the total costs of \$108,309.83 related to TC's intervention.

#### 4.0 Board Findings

The Board has reviewed the Cost Applications by TC, as well as the comments provided by MPI. The Board finds that TC meets all of the requirements for a cost award. The Board further finds that the costs incurred by TC are reasonable and the Board is prepared to award an amount of \$108,309.83 for TC's intervention in the Board's review of Manitoba Public Insurance's 2024/25 GRA and R&V.

#### 5.0 IT IS THEREFORE ORDERED THAT:

1. The Application of the Taxi Coalition for an award of costs BE AND IS HEREBY APPROVED in the total amount of \$108,309.83.
2. Manitoba Public Insurance pay Myers LLP within 15 days of the date of this Order.


Board decisions may be appealed in accordance with the provisions of Section 58 of *The Public Utilities Board Act*, or reviewed in accordance with Section 36 of the Board's Rules of Practice and Procedure.
